 - c. \$195.00 vehicle release fee is due at time of release.
 - d. \$20.00 a day storage fee if your vehicle was stored on City of Ripon property.

A Stipulated release can only be issued if the following criteria is present:

1. Registered Owner(s) only has/have one vehicle registered to them
2. The Registered Owner(s) was/were not driving at the time of tow
3. The Registered Owner(s) has/have a valid license

****Note:** If the registered owner was the driver at the time of the tow and the registered owner's Driver's License is/was suspended the vehicle **CANNOT BE RELEASED.**

****EXCEPTION TO OVERRIDE 30 DAY HOLD:**

14607.6(d) (1) This subdivision applies only if the driver of the vehicle is a registered owner of the vehicle at the time of impoundment, Except as provided in paragraph (5) of subdivision©, if the driver of a vehicle impounded pursuant to subdivision(c) was a registered owner of the vehicle at the time of impoundment, the impounding agency shall authorize release of the vehicle if, within three days presents his or her valid driver's license, including a valid temporary California driver's license or permit, to the impounding agency. The vehicle shall then be released to a registered owner of owner of record at the time of impoundment, or an agent of that owner authorized in writing, upon payment towing and storage charges related to the impoundment, and any administrative charges authorized by Section 22850.5, providing that the person claiming the vehicle is properly licensed and the vehicle is properly registered.
